Note: Nominees must have been licensed for minimum of five (5) years and must have actively served on at least two NWLAR committees. This is a three-year term with four (4) positions to be elected. The exact number of Designated REALTOR® spots, REALTOR® spots, and possible terms less than three-years to be filled will be determined after the Officer Elections are held. NWLAR By-Laws state 51% (10 of 18) members must be Designated REALTORS®, or individuals who are sole proprietors, partners, or corporate officers, or branch officer managers as defined in Article IV, Section 1(a) 1, who are acting on behalf of the Designated REALTOR®.
